

INC has been receiving various representations regarding the promotion of Nursing faculty in Nursing Institutions. INC has gazetted Revised Regulations and curriculum for B.Sc(N) program Regulations, 2020 dated 05.07.2021 which is available on INC website <https://indiannursingcouncil.org/uploads/pdf/162581803399632881260e803b133fde.pdf>

Qualification & experience of teachers of College of Nursing are laid down in the Revised B.Sc(N) syllabus under heading of teaching faculty. The guidelines for post, qualifications & experience of teachers in College of Nursing under various posts like Tutor, Assistant Professor, Associate Professor, Professor, Vice-Principal cum Professor and Principal cum Professor has been laid down.

Requisite qualification and experience is applicable for promotion of teaching faculty in nursing institutions & the above guidelines have to be followed for the promotion of faculty.

Further, the number of nursing departments & number of teachers required for student intake is mentioned with year wise no. of nursing faculty. INC has also clearly stated that the salary of the teaching faculty in private Colleges of Nursing should not be less than what is admissible in the Colleges of Nursing under State/Central Government or as per the UGC scales.
